2 **A LAW OF THE MUSCOGEE (CREEK) NATION APPROPRIATING FUNDS TO**
3 **BE USED FOR THE OPERATING BUDGET FOR THE NEWLY PURCHASED**
4 **HOSPITAL, FORMERLY KNOWN AS THE CANCER TREATMENT CENTERS**
5 **OF AMERICA – TULSA, LOCATED IN TULSA, OKLAHOMA, FOR THE**
6 **REMAINDER OF FISCAL YEAR 2021**

7 **Be it enacted by the National Council of the Muscogee (Creek) Nation:**

8 **SECTION ONE. NEW LAW. The following new Law is hereby enacted:**

9 **Section 1-101. Findings. The National Council Finds that:**

10 A. Tribal Resolution, TR 21-098, authorizes the Principal Chief to execute a
11 Purchase and Sale Agreement on behalf of the Muscogee (Creek) Nation in order
12 to purchase the real and personal property, tangible and intangible, owned or held
13 by Expedition Properties, LLC and take over operations at the Hospital located at
14 10109 East 79th Street, Tulsa, OK, formerly known as the Cancer Treatment
15 Centers of America, Tulsa.

17 B. Funding is needed in the amount of Sixteen Million, Seven Hundred
18 Seventy-Five Thousand, Five Hundred Fifteen and No/100 Dollars
19 (\$16,775,515.00).

21 **SECTION TWO. PURPOSE. The purpose of this Act is to appropriate the funds**
22 **necessary to cover the operating budget for the remainder of the fiscal year for the**
23 **new hospital as described above.**

25 **SECTION THREE. APPROPRIATION. The sum of Sixteen Million, Seven**
26 **Hundred Seventy-Five Thousand, Five Hundred Fifteen and No/100 Dollars**
27 **(\$16,775,515.00) is hereby appropriated from the Health Third Party Investment**

1 Fund Account to cover the operating budget of the new Hospital as described
2 above for the remainder of the fiscal year. Said appropriation shall carry forward
3 until fully expended.

5 **SECTION FOUR. AUTHORIZATION.** The sum of Sixteen Million, Seven Hundred
6 Seventy-Five Thousand, Five Hundred Fifteen and No/100 Dollars
7 (\$16,775,515.00) is hereby appropriated from the Health Third Party Investment
8 Fund Account to cover the operating budget of the new Hospital as described
9 above for the remainder of the fiscal year.
