A TRIBAL RESOLUTION OF THE MUSCOGEE (CREEK) NATION AUTHORIZING THE
PRINCIPAL CHIEF TO EXECUTE AN MEMORANDUM OF UNDERSTANDING WITH
THE MUSCOGEE (CREEK) NATION AND THE SEMINOLE NATION OF OKLAHOMA
FOR THE SHARED USE OF COURTROOMS

Be it resolved by the National Council of the Muscogee (Creek) Nation:

**CLASSIFICATION: 25-Inter-Government and Inter-Tribal Relations** 

WHEREAS, Article VI, Section 7(b) of the Muscogee (Creek) Nation Constitution empowers the National Council to negotiate with federal, state and local governments; and

WHEREAS, the Muscogee (Creek) Nation District Court ("District Court") has a duty to protect the due process rights of defendants as well as provide for the safety and security of court personnel, attorneys and litigants; and

WHEREAS, the Muscogee (Creek) Nation and the District Court are desirous of entering into an inter-governmental Memorandum of Understanding with the Seminole Nation of Oklahoma for the shared use of courtrooms in accordance to the Memorandum of Understanding to conduct judicial hearings; and

WHEREAS, the additional courthouse space would enable the District Court to enhance and strengthen the timely and secure administration of justice to the citizens; and

WHEREAS, nothing in the agreement transfers additional rights, jurisdiction, responsibilities, or other obligations to either the Seminole Nation of Oklahoma or the Muscogee (Creek) Nation; and

WHEREAS, nothing in the agreement waives the sovereign immunity of the Muscogee (Creek) Nation; and

 WHEREAS, the Memorandum of Understanding is an agreement between the Nation and the Seminole Nation of Oklahoma; therefore, requiring National Council approval.

**NOW THEREFORE BE IT RESOLVED THAT**, the National Council hereby authorizes the Principal Chief to execute the attached Memorandum of Understanding between the Muscogee (Creek) Nation and the Seminole Nation of Oklahoma for the shared use of courtrooms.

**BE IT FURTHER RESOLVED THAT**, in the event that the Memorandum of Understanding with the Seminole Nation of Oklahoma needs to be further renewed or extended, the National Council hereby authorizes the Principal Chief to execute a renewed or extended Memorandum of Understanding, provided that the terms and conditions remain substantially the same, do not waive the Nation's sovereign immunity, and are first reviewed and approved by the Office of the Attorney General.
