4 **Be it enacted by the National Council of the Muscogee (Creek) Nation:**

6 **SECTION ONE. NEW LAW. The following new Law is hereby enacted:**

8 A. The Muscogee (Creek) Nation has a unique relationship with the Federal,
9 State and County Government; and there is a shortage of elected officials who
10 represent the best interest of Native Americans.

12 B. The opportunity presents itself to financially support Jerry Shoemake,
13 political candidate, with a monetary contribution to his campaign as he seeks re-election
14 to the Oklahoma House of Representatives.

16 C. Per MCNCA, Title 35 §12-103. A., Mr. Shoemake is eligible to receive a
17 donation in the amount of \$2,000.00.

19 **SECTION TWO. PURPOSE. The purpose of this Act is to appropriate a campaign**
20 **donation to Jerry Shoemake, Oklahoma House of Representatives.**

22 **SECTION THREE. APPROPRIATION. The amount of Two Thousand and No/100**
23 **Dollars (\$2,000.00) is hereby appropriated from the _____ Fund**
24 **Account for the implementation of this Act.**

26 **SECTION FOUR. AUTHORIZATION. The National Council hereby authorizes the**
27 **Principal Chief or his designee to expend the sum of Two Thousand and No/100 Dollars**
28 **(\$2,000.00) from the _____ Fund Account to Jerry R. Shoemake,**
