5 **Be it Enacted by the National Council of the Muscogee (Creek) Nation:**

7 **SECTION ONE. NEW LAW. The following new Law is hereby enacted:**

9 **Section 1-101. Findings. The National Council finds that:**

11 **A. The Special Academic/Extra Curricular Program is requesting a**  
12 **supplemental appropriation to the Fiscal Year 2012 budget in the amount of Forty**  
13 **Thousand and No/100 Dollars (\$40,000.00).**

14  
15 **B. The supplemental funds are for 160 students at Two Hundred and Fifty**  
16 **and No/100 Dollars (\$250.00) per student for Seven weeks.**

17  
18 **SECTION TWO. PURPOSE. The purpose of this Act is to authorize a supplemental**  
19 **appropriation to the Special Academic/Extra Curricular Program fiscal year 2012**  
20 **budget.**

21  
22 **SECTION THREE. APPROPRIATION. The sum of Forty Thousand and No/100**  
23 **Dollars (\$40,000.00) is hereby appropriated from the \_\_\_\_\_ **Fund Account** for**  
24 **the implementation of this Act in accordance with the attached budget. All unexpended**  
25 **funds appropriated by the implementation of this Act shall carry over to the new fiscal**  
26 **year.**

27  
28 **SECTION FOUR. AUTHORIZATION. The National Council hereby authorizes the**  
29 **Principal Chief or his designee to expend the sum of Forty Thousand and No/100**  
30 **Dollars (\$40,000.00) from the \_\_\_\_\_ **Fund Account** for the Special**  
31 **Academic/Extra Curricular Program Fiscal Year 2012 budget.**

Notes:

We currently have 20 students waiting to be funded, totaling \$6591.76.
