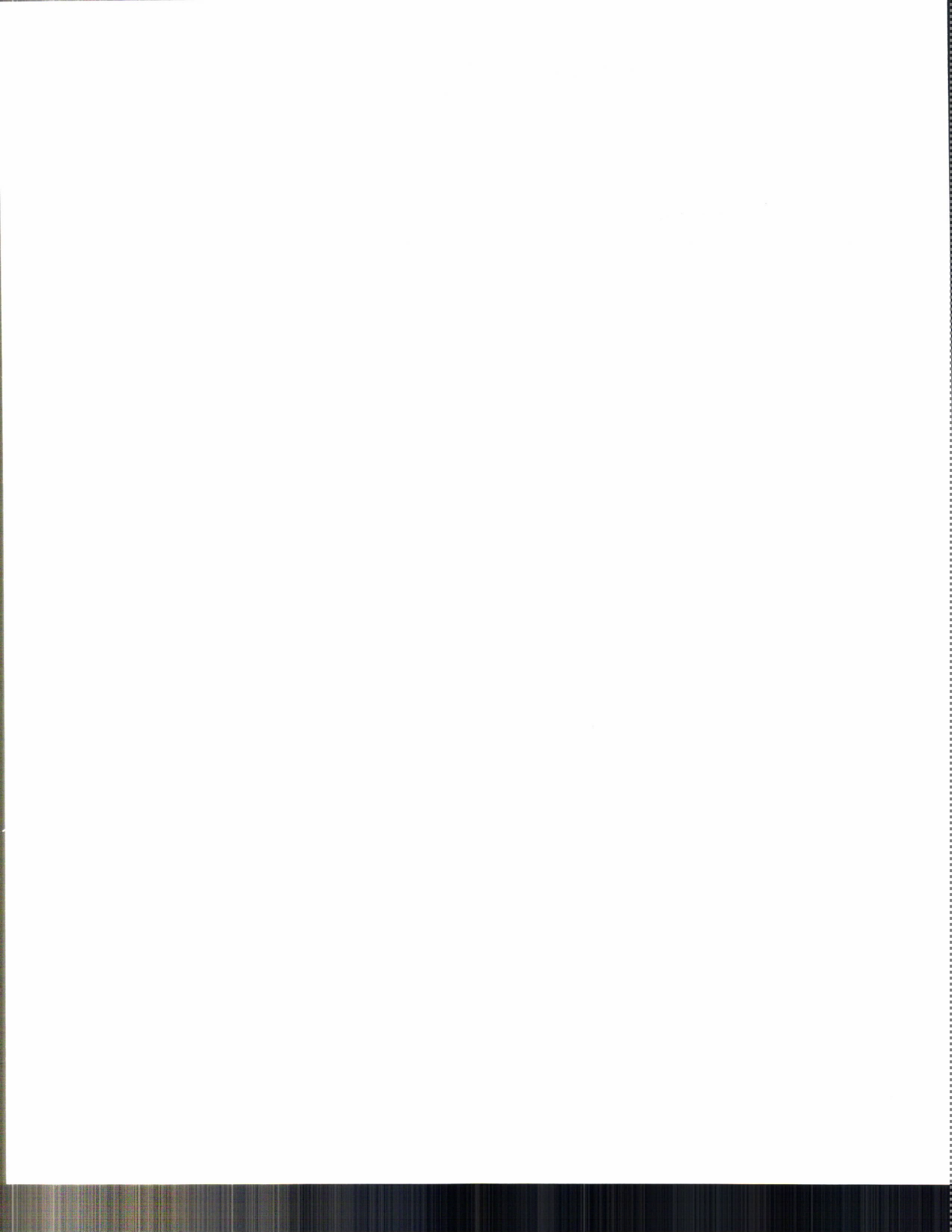

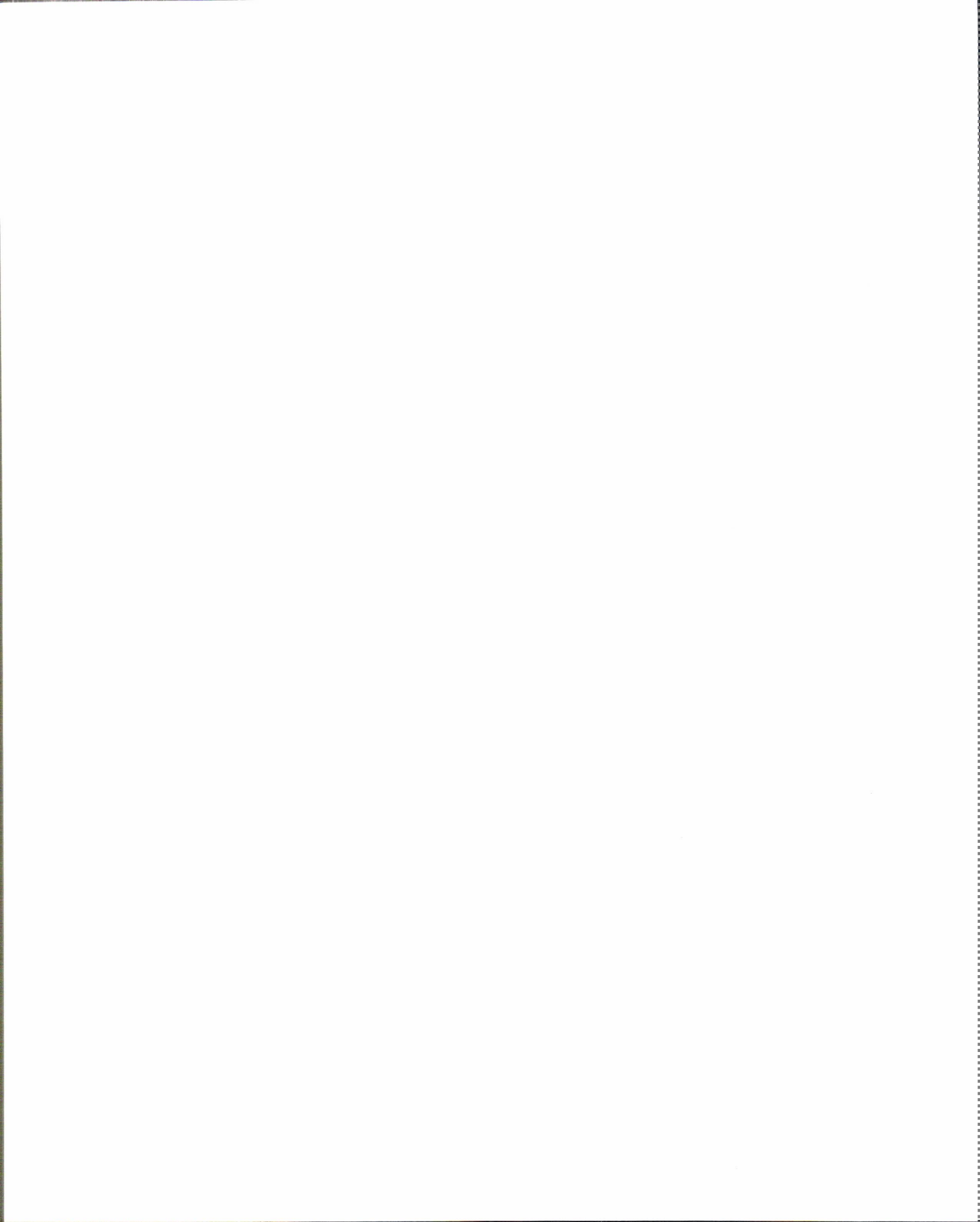


ADJOURNMENT:


