Representative James Jennings made a motion to **Amend TR 19-107 Page 2 to “insert” BE IT FURTHER RESOLVED THAT, the Muscogee (Creek) National Council hereby authorizes**

the Principal Chief to execute any and all additional agreements with FEMA, U.S. Department of Homeland Security, or other federal agencies, necessary to finalize federal disaster relief assistance so long as the agreements are first reviewed by the Office of the Attorney General. 
