#### College of the Muscogee Nation Board of Regents

Representative James Jennings reported the Board met September 13, 2021. The Natural Resources/Cultural Arts building is completed. The Exhibit/Lecture Hall is thirty days out on the final design and the RFQ for construction and the GMP will be completed around February 1, 2021. An election was held and the officers of the Board are as follows: Mike Flud, Chair, Dr. Dean Hughes, Vice-Chair and Pandee Ramirez, Secretary. The enrollment for the fall 2021 semester is 225 students. CMN President, Dr. Monte Randall was recently selected as one of the Aspen New Presidents Fellowship recipients. Out of twenty-five Presidents, Dr. Randall was the only President that was chosen from Oklahoma and a tribal college.

#### Mvskoke Loan Fund Board
