#### Muscogee Nation Gaming Enterprise Board

Representative Randall Hicks reported that the Board met January 4, 2023. Reports were given by CEO Pat Crofts, COO Andy Langston and Board Attorney Yonne Tiger. The Board also met on January 18, 2023. Financials were emailed to the full council. The Board's next meetings are February 1 and 15, 2023 at 6:00 p.m.

#### Muscogee Nation Business Enterprise Board

Representative Sandra Golden reported that the Board met on December 29, 2022. Their total distribution to the Nation is approximately \$179,000.00. They are still looking for office space. The next Board meeting is January 26, 2023 at 5:00 p.m.

#### College of the Muscogee Nation Board of Regents

Representative Anna Marshall reported the Board met January 9, 2023. CMN had its largest enrollment for this semester at 262 students. The Natural Resources and Cultural Arts building is almost completed. They are installing light poles and fixtures and other finishing touches. The foundation has been laid for the Exhibit Hall building. The anticipated completion date for this building is December 2023. They are in the second phase of the CMN marketing plan. They have completed letterheads and signature lines for future radio and television ads for recruiting purposes. They have completed their strategic plan. The college is working on the Mvskoke language revitalization with a master apprentice program and project to have twenty fluent speakers from that. They are working with Emory University with an Emory University grant. The next Board meeting will be February 1, 2023.
