## **REQUIREMENTS:**

Muscogee (Creek) “Traditional” Churches (50 years or older or churches that can provide documentation demonstrating eighty percent (80%) of membership are Tribal Citizens within the Nation’s jurisdictional boundaries) shall be eligible to apply to receive assistance for a summer Church camp or a mission trip every two years and are required to raise half of the amount of total budget. The Church shall be eligible for assistance for the remaining half, but no more than \$2,500.00.

- 1) A completed application: and
- 2) A letter from the Pastor supporting request to the National Council Office. If there is no Pastor, a Church Officer, Deacon or women’s leader may make same request.
- 3) A line item budget of camp or mission trip; and
- 4) List of Muscogee (Creek) Citizens:
  - a. Summer Church Camp – preferably copies of citizenship cards or names with roll numbers of ten or more members attending;  
or
  - b. Mission Trip - preferably copies of citizenship cards or names with roll numbers of five or more members attending

If a Church fails to raise half of its total budget, the Church shall be required to return the funds awarded.

Receipts for total amount of funds allocated must be turned into the National Council Office within thirty (30) days of the conclusion of the Church camp or mission trip. Failure to comply may require full restitution of any and all funds received and Payee may be prohibited from receiving any future funds.
